

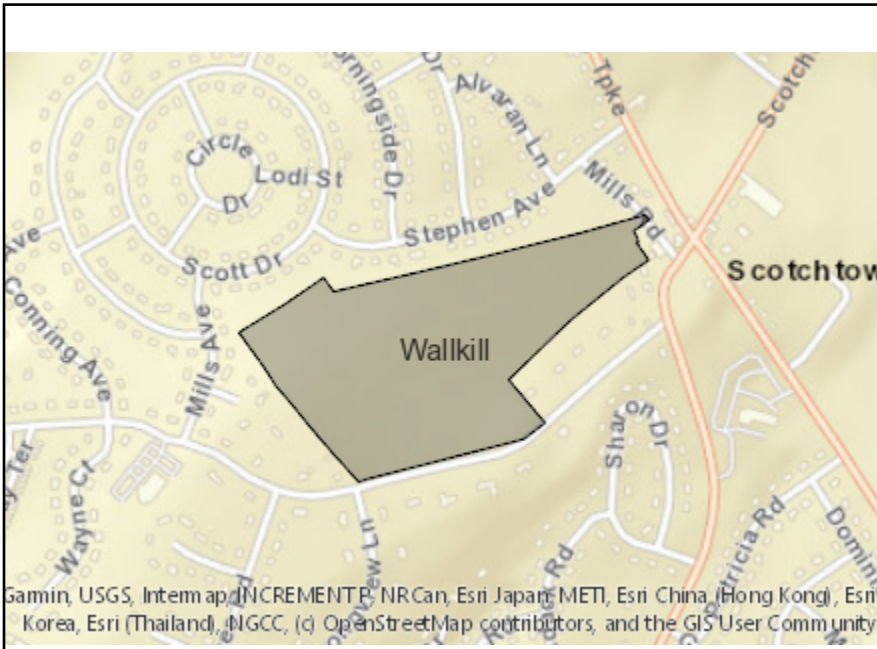

Brief Description of Proposed Action: The proposed action consists of the construction of a twenty (20) lot conservation subdivision on tax lot 24-1-83. Seventeen (17) lots will front a proposed 24-foot wide residential road (ending at a cul-de-sac) and three (3) lots will front Silverlake-Scotchtown Road. The subject property is situated in the R-2 zoning district of the Town of Wallkill. The conservation area is approximately ±20 acres and will be used to conserve an on site wetland area and provide a buffer for adjacent existing residences.
