**RESOLUTION OF THE TOWN BOARD OF THE TOWN OF WALLKILL
AUTHORIZING THE TOWN SUPERVISOR TO ENTER INTO AGREEMENTS FOR
POLICE SERVICES WITH LOCAL CATERING ESTABLISHMENTS**

WHEREAS, certain catering businesses within the Town experience traffic control problems during events such as high school proms; and

WHEREAS, the operators of Villa Venezia and The Barn at Villa Venezia, both located on Goshen Turnpike within the Town, have expressed a desire to enter into agreements with the Town of Wallkill for a police presence of uniformed Town of Wallkill Police Officers at said locations within the Town on certain days when high school proms are being held to assist with traffic control and related services; and

WHEREAS, the Town of Wallkill is willing to enter into such agreements provided that all expenses associated therewith are paid by the catering businesses and that such agreements will not interfere with normal police operations and patrol within the Town; and

WHEREAS, the Town Board believes that it is in the overall best interest and public safety of the residents of the Town to enter into such agreements,

NOW, THEREFORE, LET IT BE HEREBY

RESOLVED, that the Town Board of the Town of Wallkill hereby authorizes the Town Supervisor or his designated representative to enter into agreements for traffic control police services with the operators of Villa Venezia and The Barn at Villa Venezia, which agreements shall be subject to the review and approval of the Town Attorney.

**RESOLUTION OF THE TOWN BOARD OF THE TOWN OF WALLKILL
AUTHORIZING THE TOWN SUPERVISOR TO EXECUTE A CONTRACT FOR
TEMPORARY LIGHTING AND SIGNAGE SERVICES FOR THE INDEPENDENCE
DAY HOLIDAY EVENT**

WHEREAS, the Town of Wallkill is presently in need of a temporary lighting and signage vendor to provide services at the Town sponsored Independence Day Celebration to be held at the Town of Wallkill Golf Course; and

WHEREAS, the Town has attempted to obtain proposals for the provision of such services; and

WHEREAS, the Town Board has selected the vendor which offers the Town the most economical lighting and signage equipment for the event,

NOW THEREFORE, IT IS HEREBY

RESOLVED, that the Town Board of the Town of Wallkill hereby authorizes the Town Supervisor, or his designee, to execute a contract with Sunbelt Rentals of Clifton, New Jersey to provide temporary lighting and signage equipment services at the Town sponsored Independence Day Celebration to be held at the Town of Wallkill Golf Course at a cost of \$13,870.80 and said contract, which is annexed hereto, shall be subject to review and approval by the Town Attorney.
